Sept 14-15; 16-17; 21-22	Algebra 1 EOC Fall Retakes (2-day tests)	MC (AM/PM)	Students who were absent/invalidated in previous FSA Algebra 1 EOC administrations or wish to meet the required Mathematics graduation requirement.
Sept 23-24	SAT (non-reportable)	MC (All day)	12 th grade students (by credit) who have not met the ELA and/or the Algebra 1 EOC graduation requirement. They will test over 2 days using extended time. This administration is non-reportable and may not be used for college admission.
Sept 29, 30 Oct 19, 20	FSA ELA 10 Writing (1-day test) Required to take before FSA ELA 10 Reading	MC (AM only)	Students in grades 11 and 12 who are currently enrolled in an Intensive Reading course.
Oct 1-2; Oct 21-22	FSA ELA 10 Reading (2-day test) Required to take Writing Test (above) before FSA ELA 10 Reading	MC (AM/PM)	Students in grades 11 and 12 who are currently enrolled in an Intensive Reading course.
Sept 28- Oct 30	FSAA Make Up	NGC/MC	Students with Severe Cognitive Disability (ELA 10 and Algebra EOC)
Oct 6-9	9-week exams	NGC/MC	Teacher/PLC made exams except for State EOC courses: US History, Algebra 1, Geometry, ELA 9 and ELA 10 Oct 6-Per 2; Oct 7-Per 1 & 3; Oct 8-Per 4 & 6; Oct 9-Per 5 & 7
Oct 14	SAT School Day	MC	SAT for 12 th grade students. Seniors with certain College Board approved accommodations will test over 2-days
Oct 15	SAT (Day 2 for College Board approved seniors)	MC	Seniors (by credit) with certain College Board approved accommodations.
Nov 2-3; 4-5	FSA Geometry EOC (2-day test)	MC (AM/PM)	Students who were absent/invalidated for previous FSA Geometry EOC administrations.
Nov 4-5	Biology & US History EOC Retakes (1-day test)	MC (AM)	Any student needing to complete the End-of-Course exam for either one of these courses.
Nov 12	PERT (Algebra 1 Comparative/Dual Enrolled)	MC	Students who have completed Algebra I and have not achieved proficiency on the Algebra I EOC or PERT
Dec 1-2	FSA Geometry EOC (2-day Test)	MC (AM/PM)	Students who were absent/invalidated for previous FSA Geometry EOC administrations.
Dec 1, 2, 7 and 8	FSA ELA 10 Writing 1-day Test	MC (AM/PM)	Students enrolled in English 3 must take the FSA ELA 10 Writing and Reading Exam. Writing must be taken prior to Reading.
Dec 3-4; 9-10	FSA ELA 10 Reading (2-day test) Required to take Writing Test (above) before FSA ELA 10 Reading	MC (AM/PM)	Students enrolled in English 3 must take the FSA ELA 10 Writing and Reading Exam. Writing must be taken prior to Reading.
Dec 6 & 9	Biology & US History EOC Retakes (1-day test)	MC (AM)	Any student needing to complete the End-of-Course exam for either one of these courses.
Dec 15-18	9 Week Exams	NGC/MC	Teacher/PLC made exams except for State EOC courses: US History, Biology, Algebra 1, Geometry, ELA 9 and ELA 10 Dec 15-Per 2; Dec 16-Per 1 & 3; Dec 17-Per 4 & 6; Dec 18- Per 5 & 7
